Staff recommends that the Board approve the total disbursements for the month of September 2024 in the amount of \$22,191,162.79.

Staff recommends that the Board:

- Adopt Resolution No. 2024-11-1, approving the application for financial assistance provided by the California Office of Emergency Services, Homeland Security and Emergency Management for the State and Local Cybersecurity Grant Fiscal Year 2024/25; and
- 2. Appoint the General Manager or designee to conduct all negotiations, execute, and submit all documents including, but not limited to, applications, agreements, and payment requests on behalf of the Agency in compliance with applicable state and federal laws.

# D. <u>ADOPT RESOLUTION NO. 2024-11-2 FOR US BUREAU OF RECLAMATION WATERSMART WATER AND ENERGY EFFICIENCY GRANT FOR FISCAL YEAR 2025 GRANT APPLICATION</u>

Staff recommends that the Board adopt Resolution No. 2024-11-2, authorizing the General Manager or his designee to execute the United States Bureau of Reclamation (USBR) WaterSMART Water and Energy Efficiency Grant assistance agreement and to submit all required documents to USBR.

#### E. AWARD SERVICE CONTRACT FOR UNIFORM SERVICES

Staff recommends that the Board:

- 1. Award a service contract to Cintas Corporation for uniform services, for a two-year period, with the option of three one-year extensions, for a total potential contract term of five years, for an aggregate not-to-exceed amount of \$1,000,000; and
- 2. Authorize the General Manager to execute the contract, subject to non-substantive changes.

### F. ADOPT SOLE SOURCE STANDARDIZATION OF COMBINATION AIR AND VACUUM RELIEF VALVES FOR AGENCYWIDE PIPING

Staff recommends that the Board:

- 1. Adopt a standardization finding pursuant to Public Contract Code 3400(c) that (2) in order to match other products in use on a particular public improvement either completed or during completion and (3) in order to obtain a necessary item that is only available from one source; it is valid to use A.R.I. combination air and vacuum relief valves for recycled water and wastewater piping, ancillary systems, and spare parts for ongoing and future maintenance; and
- 2. Authorize the standardization selection and sole source procurement for future operations, maintenance, and capital projects.

# G. AWARD MASTER SERVICES CONSULTANT CONTRACTS FOR ON-CALL ENGINEERING SERVICES

Staff recommends that the Board:

- 1. Award consultant master services contracts to Awad Engineering, Inc., Black & Veatch Corporation, Brown and Caldwell, Carollo Engineers, Inc., CDM Smith Inc., GHD Inc., Lee + Ro, Inc., MKN & Associates, Inc., Parsons Water & Infrastructure Inc., Stantec Consulting Services, Inc., Water Systems Consulting, Inc., and WSP USA Inc. for on-call engineering services, for a five-year period, with the option of two one-year extensions, for a total potential contract term of seven years, for an aggregate not-to-exceed amount of \$25,000,000; and
- 2. Authorize the General Manager to execute the contracts, subject to non-substantive changes.

- 4. Authorize the General Manager to execute the contracts and contract amendment, subject to non-substantive changes.

- 2. Authorize the General Manager to finalize and execute the contract with one Energy Service Provider, subject to non-substantive changes.
